## **Course Description**

Our goal in this seminar is to work through a small handful of classic texts in the philosophy of language, texts that are essential background for any contemporary student of philosophy. The topics we will cover—reference, content, truth—cast a long shadow, influencing work well beyond the narrow confines of philosophy of language.

## Requirements

Short paper (2-3 pages): due week 3.

We will divide the task of grading these short papers: half of the papers will be graded by Ben, half by David. You will be required to revise and resubmit your short paper until it is judged satisfactory by he who graded it. Your grade for the paper will be based upon the final revision.

Seminar paper (10-15 pages): draft due week 6, final paper due at the end of finals week.

We will both comment on the draft and jointly grade the final paper. You will be required to meet with each of us to discuss comments on your draft and develop a revision strategy.

### Presentations

You will be required to do one 10-15 minute presentation and to comment on someone else's 10-15 minute presentation. Because our schedule of readings is flexible, you should not expect to know for certain what topic you will be presenting on more than a week in advance.

## Participation

As much as possible, we intend to put this seminar in your hands. We expect each of you to come to class each week ready to dig in. Proper preparation requires, not just that you have read the material, but that you are ready to lead

us all in a discussion of the material, and we expect each of you to be so prepared each week.

#### Grade

Your grade will be a calculated as a function of your moral worth.

### **Texts**

You should purchase Kripke's *Naming and Necessity* (ISBN: 0674598466). Other papers will be made available online or as photocopies.

## **Readings**

Our readings will be dictated by how fast we go. It is possible to spend an entire quarter on the first page of "On Sense and Reference." While we wish to avoid that extreme, our goal is not to rush through the material to get to the end: this course is a beginning, not an end.
